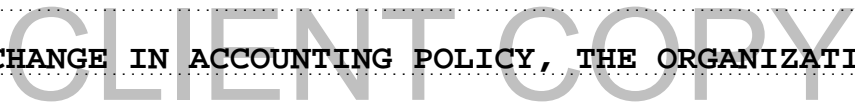

HOWEVER, THE ORGANIZATION BELIEVES THAT A MAJORITY OF LAND TRUSTS USE THE ZERO VALUATION METHOD. THE ORGANIZATION BELIEVES THAT THE ZERO VALUATION METHOD BETTER REFLECTS ITS FINANCIAL POSITION SINCE THE EASEMENTS DO NOT HAVE ANY FAIR MARKET VALUE IN THE HANDS OF THE ORGANIZATION AND, AS SUCH, PROVIDE NO MONETARY SUPPORT FOR CONTINUING OPERATIONS.
