DURING FISCAL YEAR 2015, THE ORGANIZATION ADOPTED THE ZERO VALUATION APPROACH TO REPORTING CONSERVATION EASEMENTS FOR PURPOSES OF THE STATEMENT OF FINANCIAL POSITION, THE STATEMENT OF ACTIVITIES, THE STATEMENT OF FUNCTIONAL EXPENSES AND THE STATEMENT OF CASH FLOWS. THIS CHANGE IN ACCOUNTING POLICY WAS APPLIED RETROACTIVELY TO ALL PERIODS PRESENTED IN THE 2015 FINANCIAL STATEMENTS RESULTING IN A DECREASE IN PERMANENTLY RESTRICTED NET ASSETS AND TOTAL NET ASSETS OF APPROXIMATELY \$5,096,751 AS OF JANUARY 1, 2013.

PRIOR TO THIS CHANGE IN ACCOUNTING POLICY, THE ORGANIZATION RECORDED ITS CONSERVATION EASEMENTS AT THE VALUE PAID TO ACQUIRE THE CONSERVATION EASEMENTS.

THERE IS NO AUTHORITATIVE LITERATURE ON THE ACCOUNTING FOR CONSERVATION EASEMENTS RESULTING IN A DIVERSITY OF PRACTICE AMONG LAND TRUSTS. HOWEVER, THE ORGANIZATION BELIEVES THAT A MAJORITY OF LAND TRUSTS USE THE ZERO VALUATION METHOD. THE ORGANIZATION BELIEVES THAT THE ZERO VALUATION METHOD BETTER REFLECTS ITS FINANCIAL POSITION SINCE THE EASEMENTS DO NOT HAVE ANY FAIR MARKET VALUE IN THE HANDS OF THE ORGANIZATION AND, AS SUCH, PROVIDE NO MONETARY SUPPORT FOR CONTINUING OPERATIONS.
